NON-CONSENT AGENDA ITEMS

C. Council will discuss and may recommend approving the payment to Drill Tech for the replacement of the column pipe to meet AIS regulations and completing WIFA requirements.

- Mayor Moore read the item and explained that we have already received the WIFA monies and needed to prove to them that the pipe in the ground was American made. We removed the pipe at a great cost, but the return will be great as well.

Councilman McNelly made a motion to approve the payment to Drill Tech for the replacement of the column pipe to meet the AIS regulations and completing WIFA requirements in the amount of \$52,202.77. Councilman Hiemenz seconded the motion, and it carried 4-0.

D. Discussion regarding possible gateway enhancement projects in coordination with the Arizona State Railroad Museum Foundation.

- Mayor Moore read the item and referred to some photographs that we furnished to them for reference.
- Al Richmond was present and available for question.
- Mayor Moore pointed out the two locations that will receive the gateway projects. One will be on Grand Canyon Blvd., and the other on West Route 66 coming into town. They will be a bit different than the current ones erected due to materials available.
- This project will take place early next spring.
- No money will be provided by the City with the exception of some in-kind service. We will be using grants that were secured through the City and the Museum Foundation.
- Councilman McNelly inquired as to the location of the railroad car.
- It will be placed on the SE corner of Grand Canyon Blvd.
- Councilman McNelly asked because of concern for individuals stopping to take

E. Mayor and Council:


- Mayor attended NACOG.
